



RSU Bartlesville Scholarship Breakfast Raffle Rules and Restrictions

\$200 in QuikTrip Gift Cards

Eligibility

The Raffle is open to legal residents who are at least eighteen (18) years of age. To enter, eligible entrants must purchase one or more raffle tickets. Tickets for the Raffle cost ten dollars (\$10) each. Tickets must be purchased prior to the drawing and while supplies last. Raffle tickets are not an admission ticket to the Fundraising Event held Friday, March 29, 2019 at the Bartlesville Community Center, Bartlesville, Oklahoma. All raffle tickets must be purchased or issued in Oklahoma or authorized jurisdiction. Participation constitutes each entrant's full and unconditional agreement to these Official Rules and the decisions of the Administrator, which are final and binding in all matters related to the Raffle. Winning the Raffle is contingent upon fulfilling all requirements set forth herein. The Raffle consists of a random winner drawing.

Timing

The Raffle begins on March 1, 2019, 8:00 a.m. and ends on March 29, 2019 at approximately 10:00 am CST (the "Raffle Period").

How to Enter

To participate in the Raffle, you must purchase one (1) or more raffle tickets during the Raffle Period. Raffle tickets are ten U.S. dollars (\$10) per ticket. Winners need not be present at the drawing to win.

Verification of Winner

The potential winners are subject to verification by the Administrator, whose decisions are final and binding in all matters related to the Raffle. The potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winners will be notified by mail, email, or phone. If a potential winner of the prizes cannot be contacted, or prizes are returned as undeliverable, such potential winner forfeits the prize. In the event the prize winner is disqualified for any reason, Administrator will award the prize to an alternate winner by random drawing among all remaining eligible entries.

Prizes

Grand Prize Winner: QuikTrip Gift Cards totaling \$200 (Approximate retail value \$200).

Limitations of Liability

The Released Parties are not liable for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the Raffle; (2) unauthorized human intervention in any part of the entry process of the Raffle; (3) technical or human error which may occur in the administration of the Raffle or the processing of entries; or (4) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Raffle or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Raffle.

Disputes

Except where prohibited, entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by a state court located in Bartlesville, Oklahoma; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle, but in no event attorney's fees; and (3) under no circumstances will entrant be permitted to obtain awards other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Administrator in connection with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of Oklahoma, without giving effect to any choice of law or conflict of law rules (whether of the State of Oklahoma or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Oklahoma.

Presence at the March 29, 2019, Bartlesville Scholarship Fundraising Event is not required to win.
