Because the program attracts students from various disciplines, meeting with mentors in their respective disciplines has proved vital to student success. Most students maintain regular, weekly meeting with their mentors. Those who do not tend to perform not as well on subsequent assignments.

Students entering BGS 3003 tend to have had very little training in research methodology. Thus, it is imperative that students begin learning about different methodologies in their disciplines early in the semester. Rough drafts of this assignment are due by week 3 and final drafts by week 5. Students who are still shaky in their understanding of methodology have the rest of the semester to continue learning about how to conduct their research before submitting their capstone proposals. Most students, especially those working closely with mentors, show significant improvement.

H. Conclusions

The annotated bibliography, which is the second major assignment in BGS 3003, invites students to collect and review sources for their capstone research. In most cases, students showed a marked improvement from the first assignment (viz., research and methodology statement). This assignment, which is due by the eighth week of the semester, provides the instructor with a handle on what students have read and what research they might still need to do.

The literature review and research/methodology section constitute two major parts of their capstone projects. Students early in the semester are expected to submit a literature review, which depicts the current state of scholarship related to the problem being engaged in the capstone project. It assesses the scholarship conducted hitherto and identifies areas in which work still needs to be done. The research/methodology section is a more mature version of the research/methodology statement written for BGS 3003. Students benefits from thinking about their projects in terms of sections: literature review, research/methodology section, findings, and conclusions.

If students had more experience conducting serious research prior to the Junior and Senior Seminars, I expect that their performance on the projects would improve. H. Conclusions

This is the very first assignment that students complete for BGS 3003. Its purpose is to acquaint students with the course and to acquaint the instructor with his/her students. Students are asked to: (1) list their areas of concentration (i.e., minors); (2) share the titles and brief summaries of the texts and/or media that have influenced them academically; (3) identify anticipated themes, issues, goals, and/or topics of possible projects, what would make those projects unique, and what questions they seek to answer; and (4) provide short description(s) that succinctly state(s) the proposition(s)/argument(s) of their projects. This assignment gives students an opportunity, right from the start, to situate themselves in the course and to see how they will be expected to bring their past learning to bear on their capstone projects. The assignment, although not easy, is low-pressure and helps students to orient themselves to the two-semester capstone process.

Appendix

Student Learning Outcome

Student learning outcomes are the observable or measurable results that are expected of a student following a learning experience. Learning outcomes may address knowledge, skills, attitudes, or values that provide evidence that learning has occurred. They can apply to a specific course, a program of study, or an institution. Outcomes should be worded in language that clearly implies a measurable behavior or quality of student work. Outcomes should also include Bloom's action verbs appropriate to the skill level of learning expected of students.

Examples:

Students will be able to apply principles of evidence-based medicine to determine clinical diagnoses and implement acceptable treatment modalities.

Students will be able to articulate cultural and socioeconomic differences and the significance of these differences for instructional planning.

Assessment Measure

An assessment measure is a tool or instrument used to gather evidence of student progress toward an established learning outcome. Every program learning outcome should have at least one appropriate assessment measure. Learning outcomes are frequently complex, however, and may require multiple measures to accurately assess student performance. Assessment plans should try to incorporate a combination of direct and indirect assessment measures. Direct provide concrete evidence of whether a student has command of a specific subject or content area, can perform a certain task, exhibits a particular skill, demonstrates a certain quality in their work, or holds a particular value. Because direct measures tap into actual student learning, it is often viewed as the preferred measure type. Indirect measures assess opinions or thoughts about the extent of a student's knowledge, skills, or attitudes. They reveal characteristics associated with learning, but they only imply that learning has occurred. Both types of measures can provide useful insight into student learning and experiences in a program. Each also has unique advantages and disadvantages in terms of the type of data and information it can provide. Examples of common direct and indirect measures are listed below.

Direct Measures

- Comprehensive exams
- Class assignments
- Juried review of performances and exhibitions
- Internship or clinical evaluations
- Portfolio evaluation
- Pre/post exams
- Third-party exams such as field tests, certification exams, or licensure exams
- Senior thesis or capstone projects

Indirect Measures

- Graduate exit interviews
- Focus group responses
- Job placement statistics
- Graduate school placement statistics
- Graduation and retention rates
- Student and alumni surveys that assess perceptions of the program
- Employer surveys that assess perceptions of graduates
- Honors and awards earned by students and alumni.

Performance Standard

A performance standard is a clearly-defined benchmark that establishes the minimally-acceptable level of performance expected of students for a particular measure.

Examples:

At least 70% of students will score 70% or higher on a comprehensive final exam.

At least 75% of students will earn score a "Proficient" or higher rating on the Communicate Effectively rubric.

Sampling Method

Sampling method describes the methodology used for selecting the students that were assessed for a given measure. In some cases, such as most course-embedded measures, it is possible to assess all active enrolled students. In other cases, however, it is not feasible to measure the population of all potential students. In these cases, it is important that a well-designed sampling scheme be used to ensure the sample of students measured is an unbiased representation of the overall population. Where multiple instructors teach a particular course, care should be taken to assess students across all instructors, including adjuncts.

Examples:

All students enrolled in BIOL 4801 Biology Research Methods II All majors graduating in the 2016-17 academic year.

Sample Size

Sample size is the number of students from which evidence of student learning was obtained for a given assessment measure.

Results

Results are an analytical summary of the findings arising from the assessment of student performance for a particular assessment measure. Typical presentation includes descriptive statistics (mean, median, range) and score frequency distributions.

Standard Met?

This is a simple yes/no response that indicates whether the observed level of student performance for a particular measure meets or exceeds the established standard. An N/A may be used where circumstances prevented the department from accurately assessing a measure.

Conclusion

The conclusion is a reflective summary and determination of the assessment results obtained for a specific learning outcome. Questions to consider in this section include the following:

- Does the assessment evidence indicate the learning outcome is being satisfactorily met?
- Where multiple measures are used for a single outcome, do the results present a consistent or contradictory pattern?
- What are the most valuable insights gained from the assessment results?
- What strengths and weaknesses in student learning do the results indicate?
- What implications are there for enhancing teaching and learning?
- How can the assessment process be improved?
