Analysis: The number of 2014 students that exited our program was 15.. Out of the 15 students, 5 failed paramedic courses and the rest left for personal or financial reasons.

The number of 2015 students that exited our program was 9. 7 of those students failed out of the pharmacology class while 2 students left for personal reasons.

Action: Attrition and retention still remains a major problem. The faculty have implemented the use of online educational tools, such as the Mu Brady Lab to supplement student learning and understanding.

Faculty have discussed moving up the deadline application date for the paramedic program to allow students more time to get there financial aid in order.

A discussion was held at our last Advisory Committee meeting about asking some of the stakeholders to provide scholarships for EMS students in our program.
