6		ARTICLE OF THE FIRST

8	SECTION 1:	For the purpose of identification, this organization shall be given the name	
9		the Rogers State University Student Government Association (RSU	
10		S.G.A.).	
11			
12	SECTION 2:	The purpose of this organization shall be:	
13		To serve as liaison between student body and administration and faculty,	
14		to provide a network of communication among the students, organizations,	
15		faculty, and administration throughout the institution that is RSU; and to	
16		serve as the body responsible for the coordination of actions by students	
17		on campus issues, which affect the entire student body.	
18			
19	SECTION 3:	To fulfill the purpose of the organization, there shall be one distinct body	
20		within the RSU S.G.A., the Student Congress. The Student Congress shall be	
21		comprised of two (2) Representatives from each member club and	
22		organization recognized by the RSU S.G.A., two (2) senators elected from	
23		each academic department at the RSU Claremore campus, two (2) senators	
24		from the Pryor campus, and two (2) senators from the Bartlesville campus.	
25			
26	SECTION 4:	In order to conduct business for the RSU S.G.A., the Student Congress of the	
27		RSU S.G.A. shall meet no less than once each month during the academic year.	
28		The RSU S.G.A. senators will meet no less than once each month in addition to	
29		the Student Congress meeting.	
30			
31	SECTION 5:	The judicial power of the RSU S.G.A. shall be vested in a Supreme Court, and	
32		other such courts as may be set up by the Student Congress, and have	
33		jurisdiction over any inferior courts created by the Student Congress. The	
34		purpose of the Supreme Court shall be to preside over impeachment	
35		proceedings, review questions of constitutionality within the RSU S.G.A., and	
36		submit official opinions and rulings to the RSU S.G.A. The Supreme Court of	
37		S.G.A. shall meet no less than once every month during the academic year in	
38		order to review RSU S.G.A. business and minutes for the purposes of	
39		establishing validity and assuring constitutionality.

58 59 60 61 62 63 64 65	SECTION 1:	Any Constitutional Amendments shall take the form of a bill, as defined in the RSU S.G.A. Statutes and Bylaws. Bills regarding Constitutional Amendments shall require, a two-thirds (2/3) majority vote of approval of the Executive Committee members, as well as a two-thirds (2/3) majority vote of approval from the full RSU S.G.A. Student Congress and a simple majority of ballots cast by the student body in a ballot election as described in the RSU S.G.A. Statutes and Bylaws.

67 68 69 70 71 72 73 74 75 76 77	SECTION 1:	 Upon adoption of this document by the RSU S.G.A. Student Congress, it shall be presented to the full student body for its approval. The procedure shall be as follows: A. The document shall be made available to the student body for inspection and study one week prior to the ratification election. B. Announcements shall be placed in public areas allowing the student body to know of the proposed Constitution availability. C. On a set date with student body notification two weeks prior, an election shall commence for the ratification of the proposed.

81 82 83 84 85 86	SECTION 2:	Once the proposal receives a simple majority vote of approval from the student body votes cast in the election on which the proposed Constitutional change is balloted, it shall be considered law seven (7) days after the results have been certified and sealed. Furthermore, upon passage and approval of this document any and all previous constitutions shall be considered null and void.
